**A RESOLUTION AUTHORIZING EXECUTION OF A
PERFORMANCE AGREEMENT WITH
MCLEAN MOTOR SPORTS PRODUCTIONS, LLC
FOR THE “BAMA COAST CRUISIN’” EVENT**

FINDINGS:

1. McLean Motor Sports Productions, LLC, an Alabama corporation, wishes to have an event entitled “Bama Coast Cruisin’” in the City of Orange Beach.
2. The City of Orange Beach originally invited McLean Motor Sports Productions, LLC, to host the Bama Coast Cruisin’ event following the Deepwater Horizon Oil Spill in order to stimulate economic growth and boost public morale within the community by offering a free-to-the-public event. This annual event has continued to boost public morale and stimulate economic growth. McLean Motor Sports and Bama Coast Cruisin’ create incentives to encourage attendants to visit local businesses, partner with hotels in the community, and advertise the event nationally. The event and attendees have proven to be law abiding and wholesome, keeping in line with the City’s vision for a family friendly environment.
3. The City wishes to engage McLean Motor Sports Productions, LLC, to again host a free-to-the-public car show event.
4. After having reviewed the performance agreement and event statistics from previous years, the City Council has determined that the provisions serve a public purpose to wit: promoting the health, safety, morals, security, prosperity, contentment and general welfare of the community and are in the best interest of the City of Orange Beach, Alabama.
5. The term of this agreement shall be effective on and after its adoption by the City Council and execution by the Mayor, and shall continue in full force and effect through the completion of the event being held on or about April 27-29, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE BEACH, ALABAMA, AS FOLLOWS:

1. That the Council authorizes the Mayor and City Clerk to execute and attest, respectively, the Performance Agreement (attached Exhibit A) in substantially the form and of substantially the content now before the Council between the City of Orange Beach and McLean Motor Sports Productions, LLC, as an act for and on behalf of the City of Orange Beach subject to final approval by the City Attorney; and
2. That this Resolution shall become effective immediately upon its adoption.
